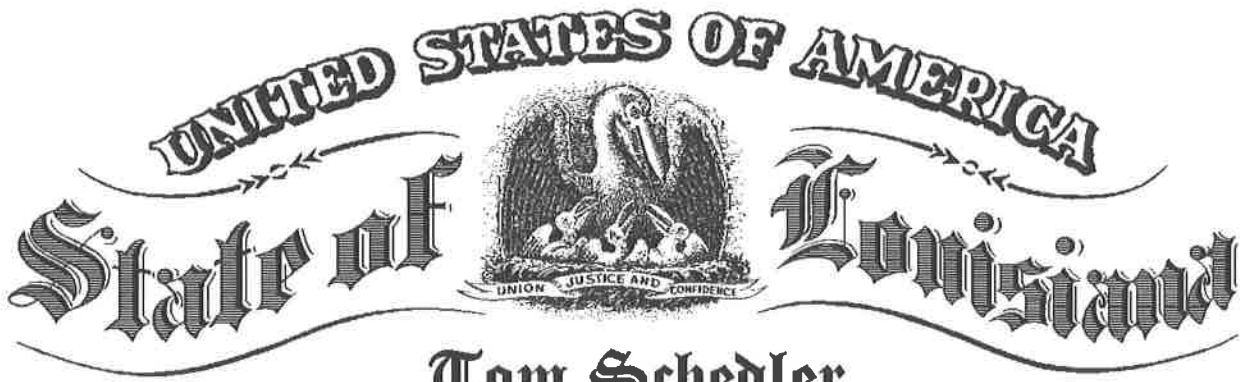

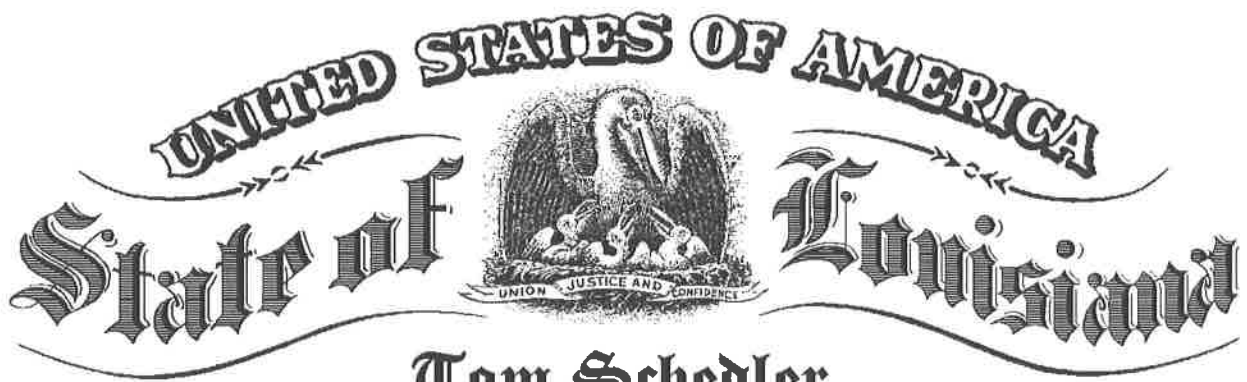

AMENDED ARTICLES OF INCORPORATION OF  
INNOCENCE PROJECT NEW ORLEANS

BE IT KNOWN that on this 21<sup>st</sup> day of September, 2016, before the undersigned authority, a Notary Public duly qualified in and for the above stated State and Parish, and in the presence of the named and undersigned competent witnesses, personally came and appeared **Innocence Project New Orleans** (“the Corporation”), a Louisiana nonprofit corporation, represented herein by Melody Chang, its duly authorized officer, by authority of its members, who does hereby certify and declare that:

**FIRST:** The date of filing of the original Articles of Incorporation of the Corporation is the 1st day of May, 2001.

**SECOND:** In accordance with La. R.S. 12:237 and the articles of the Corporation, a special meeting of the members of the Corporation was held on the 31<sup>st</sup> day of August, 2016, at which a quorum of the members entitled to vote was represented, for the purpose of amending Articles VI, VII, VIII, and XI of the articles of the Corporation.

**THIRD:** At such special meeting by a vote of two-thirds in interest of the voting members present, Articles VI, VII, VIII, and XI of the articles of the Corporation were and are hereby amended as follows:

**“ARTICLE VI**

Upon the dissolution of this nonprofit corporation, the net assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or shall be transferred to a public or private corporation, association

or agency having similar purposes as this nonprofit corporation.”

**“ARTICLE VII**

The responsibility for policy and strategic direction of this Corporation shall be vested in a Board of Directors. The number, classification, qualifications, terms of office, manner of election and appointment, time and place of meetings, and powers and duties of the Directors shall be prescribed by the bylaws.”

**“ARTICLE VIII**

The time, place, and manner of the annual meeting of the Corporation shall be prescribed by the bylaws.”

**“ARTICLE XI**

These Articles of Incorporation and the bylaws of this Corporation may be amended from time to time by the Board of Directors by a two-thirds vote of those present at a meeting called for that purpose.”

All other articles of the Corporation as set forth in the original Articles of Incorporation of the Corporation are incorporated herein by reference and shall remain in full force and effect.

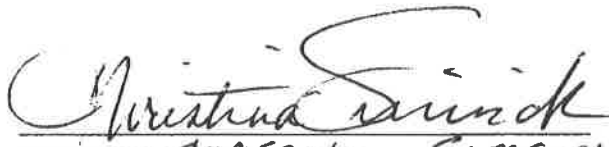

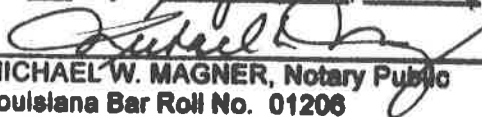
